




## Una Europa Chairs 2023: Europe & the World

FIBRE - Fostering European Integration through Bachelor Education

FIBRE aims to develop high-quality didactical materials for two truncus communis courses that are part of the Una Europa Joint Bachelor in European Studies (BAES), scheduled to be taught for the first time in 2023-24: "European Integration" and "Introduction to EU and International Law". The project brings together a significant and multidisciplinary group of senior and junior academics from seven Una Europa universities to develop two original textbooks to be published with an international publisher. These textbooks will contribute both to the quality and radiance of the BAES and to enhanced research cooperation within Una Europa. The Chairholder will spend three periods of three weeks at Alma Mater Studiorum - Università di Bologna in close interaction with the Una Europa colleagues co-teaching the two courses in order to develop the two textbooks. The development of textbook content will be initiated at a workshop in January/February 2023 and advanced in a workshop in June/July 2023. Students on the relevant BAES courses will pilot the resulting textbook chapters during academic year 2023-24. After careful review, the textbooks will be published in 2024-25.
